


Sara Riesen Bolte Real Estate Principal Broker

New... City of Sandusky Rules





It has come to our attention that the City of Sandusky, Department of Community Development, Division of Code Compliance has began to require an authorization form to enter Condemned dwellings.

David Freitag, RCE, CEO, Frank Corder, Legislative Chairman and Steve Mack, Past President met with Matt Lasko from the City of Sandusky to discuss the implementation of this new policy from the City of Sandusky. The agreement at this meeting is the following:

- If you are a REALTOR and intend on showing a condemned property in the City of Sandusky, you must download the "REALTOR Authorization to Enter Condemned Dwelling" form, fill it out and you must carry a copy of it with you while showing the property.
- Failing to do so will result in immediate removal from the dwelling and may result in criminal penalties.

Once the City of Sandusky has the link available you will be able to download it from there, also it is now available on FAOR.com under "Forms" and on dotloop.







Real Estate in a Digital Age

The world we live in today is a digital one and searching for a home is no different. Buyers now have apps that let them search by location and neighborhoods. Online searching maximizes the ability to compare and contrast homes on the market by selected features. Most of this is done before a potential home buyer connects with a real estate agent.

In the Real Estate in a Digital Age report, we examine the process home buyers go through in the initial online search and how REALTORS® are connecting with customers in the digital space.

The typical buyer used a mobile device to search for properties



online. S/he looked at websites with photos, home listings, and information about the home buying process. S/he then contacted an agent and visited a median of 10 homes over 10 weeks again in 2019 before purchasing a home.

81% of Older Millennials, 80% of Younger Millennials and 78% of Generation X found their home on

a mobile device compared to 68% of Younger Boomers.

The most common feature on firms' websites were property listings at 92 percent.

Social media was the tool cited as the best source for generating high-quality leads among REALTORS®, followed by Multiple listing service (MLS) websites.

ShowingTime - For assistance please call 1.800.379.0057 or email support@showingtime.com

Multiple Areas - If you want to put a listing in more than one area, there is a \$25 charge per area. For listings entered more than once: when sold...you only sell out one of the listings and withdraw the others.

The Board of Directors recently approved the recommendation of the MLS Committee to modify the Primary Photo rule as follows:

New Primary Photo

In order to maintain consistency in the Service, primary photo as established is the front view of the property. Any photo set as the primary photo for the property that is not the front view of the property will be removed. In the event of a home having two front views (i.e. water front home) the listing agent may choose which of the two views to use as primary. If the alternate view is used as the primary, the photo of the front view of the property must be set in the second position. (Amended 2/18)
