- **This scholarship will pay your Post Licensure class fees through The CE Shop Online**
- You will receive notice of your approval or denial within 30 days after deadline
- **Committee will award 1 Post-Licensing Scholarship each year, Subject to availability of funds***
- **You will receive a deadline to begin classes and complete classes, if an extension is needed you must call the Board Office to request an extension, this will not extend the ODRE (Ohio Division of Real Estate) deadline requirements.**
- **You must be a Primary Board member of Firelands Association of REALTORS in good standing for a minimum of 120 days from date of licensing.**
- **You must have attended the New REALTOR Orientation within 90 days of Membership**
- **You must join and be active in a FAOR Committee with-in the first year of membership.**
- **If you fail to comply you will be held responsible for the costs of the Post-Licensure courses from The CE Shop.**
- *If you are presently enrolled in Post Licensure courses, you will not qualify.*
